Mobile Area Resource Centre (MARC) Van Visits

In 2023 we welcome the MARC Van to our school on Wednesdays during Semester 1 and Fridays during Semester 2.

The Mobile Area Resource Centre (MARC Van) is a mobile library which visits six district schools in our local area. There are thirty-five MARC Vans like this one around Victoria, each with its very own qualified MARC teacher & librarian. Ours is based at Skipton, with teacher-librarian Mrs Gayle Munson our new MARC Teacher.

MARC Vans have been operating since the 1970's. There are around 35 MARC Vans in Victoria. MARC Vans are a part of the Department of Education and were introduced to service Rural Schools with less than 100 students to provide the opportunity to borrow books from a Library Service.

The MARC van is filled with picture story books, fictional novels, and non-fiction books for students and teachers to borrow. MARC lessons allow students to share books, discuss different aspects of the books, think critically and explore issues in greater details with an activity that is appropriate.

Teacher - librarian Gayle and her MARC Van will visit our Prep and Gr 1-2 classrooms fortnightly, then our Gr 3-4 and Gr 5-6 classrooms on the alternate fortnight. We welcome Gayle to our team.

Bushfire Information for Parents - Code Red Schools

Following the tragedy of the Black Saturday fires across Victoria in 2009, the Victorian Education Department, along with the DSE, conducted a stringent analysis of bushfire risk to all kinders, childcare centres and schools.

Invermay Primary School is one of more than 100 facilities that have been identified on a Victorian Bushfire Risk Register.

What does this mean for students, parents and staff of Invermay PS?

- Schools, kindergartens and child care facilities at the highest risk of fire danger are placed on the DEECD's Bushfire At-Risk Register. Inclusion on this register is a trigger for the school, kindergarten or child care facility to pre-emptively close on days declared Code Red in their Bureau of Meteorology region.
- Schools, kindergartens and licensed child care centres that have been identified as being at high fire risk and on the Department's <u>Bushfire At-Risk Register</u> will close on days declared <u>Code Red.</u>
- The decision to close will not be made by school Principals or school based staff. The
 decision to pre-emptively close schools and children's services is made by the Department
 of Education and Early Childhood Development based on warnings issued by the Bureau of
 Meteorology and in consultation with fire and emergency services.
- Where possible, up to 3-days notice of a planned closure will be provided to parents to
 enable child care arrangements to be made. Parents and carers should, however, expect
 that in some instances fewer than 3-days notice may be provided.
- Once the final decision to close is confirmed (no later than 12 noon the day prior) this
 decision will not change regardless of any changes in the weather forecast. This will help
 limit confusion and help your family plan for how your children will be cared for when their
 school, kindergarten or child care centre is closed.
- Closure advice will be provided to you directly by your school, kindergarten or child care centre. A note and phone call should be expected wherever possible.
- When a school or children's service is advised to close on a Code Red day, no staff will attend school on that day or remain on site. All out-of-school care programs (including vacation, before and after school programs) will close.

Invermay PS is a Code Red School and will be closed on Code Red declared days in our fire district.

Schools like Invermay PS who are on the

Bushfire At Risk Register may also request special consideration for closure on days forecast to be EXTREME (one level below CODE RED). The Department of Education and Vic Emergency Management will consider these on a case by case basis, with approval being given before midday the day before, so that families may be appropriately notified.

Bushfire Information For Parents – Invermay PS

What happens if an external fire threatens our school unexpectedly with staff and students in attendance?

If, for any reason, our school comes under threat on a day not declared Code Red and where students and staff are in attendance (ie: an unexpected localised grassfire on a mild day), our plan is to assemble all students in the junior school building. (which has many fire preventative features that are explained to students and staff at our fire drill sessions)

All staff members have allocated responsibilities in our school emergency plan (which are discussed and rehearsed during our fire drills) - including but not limited to student supervision, communications with parents, liaising with emergency services and the Education Department, First Aid & monitoring radio/internet updates.

Our message for staff, students and families is simple:

- In the event of an unexpected external fire threat whilst staff and students are in attendance, we will assemble in the safest building in our school (jnr school building) and will not evacuate unless advised by the emergency services officer in command.
- 2. Whilst the Safe Meeting Point for Invermay community residents is the recreation reserve across the road from our school front, <u>our school will not rely on any one particular evacuation point</u>. Any possible evacuation will be to a point and <u>direction advised by the emergency services officer in command</u>, based on all available conditions and information at the time.
- 3. In our plan, we ask that families endeavour not to continually call our school landline phone number for updates. This will be our primary link with emergency services and the Education Department's Emergency Management team. IPS staff assigned to the family communications role will use mobile phones to contact parents/carers, particularly if an evacuation is required. Families could also seek updates on the following media:

Victorian Bushfire Information Line (VBIL) on freecall 1800 240 667.

Callers who are deaf, hard of hearing, or have a speech/communication impairment can call textphone/telewriter (TTY) on 1800 122 969.

Listen to ABC Local Radio, commercial and designated community radio stations or watch Sky News

Students will be available for collection at any time, but only by their listed
parent / carer or emergency contact. We cannot release children with friends,
neighbours etc who are not listed as an emergency contact in enrolment records.

BUSHFIRE PREPAREDNESS

In 2018 and again in 2020 and 2021, we contracted an arborist to compile a detailed report on each tree in our grounds greater than 5m in height. This report, along with bushfire preparation legislation for schools, created a number of required works to be actioned in our buildings and grounds.

We have completed \$17,000 of bushfire preparation works and arborist recommended works in recent months to ensure our grounds, buildings, students & staff are as safe as possible in the event of bushfire or ember attack.


TOTAL FIRE BAN - closure in schools

Following the tragedy of the Black Saturday fires across Victoria in 2009, the Victorian Education Department, along with the DSE, conducted a stringent analysis of bushfire risk to all kinders, childcare centres and schools.

Invermay Primary School is one of more than 100 facilities that have been identified on a

Victorian Bushfire At Risk Register (BARR).

The Education Department enforce that all schools on the BARR must closed when a CODE RED day is declared in their fire district. (see detailed info attached to today's newsletter) Thankfully, in the last 10 years our school has never been forced to close due to Code Red conditions. We do however prepare by updating parents/carers in our newsletter and on social media throughout the year, as well as discussing what this means with students. We also conduct fire drills annually with students and staff, with our most recent being on Tuesday of this week.

Invermay PS is a 'Code Red' School and will be closed on Code Red fire danger days declared in our district.

Vic Emergency Management and the Department of Education will also consider special consideration for closure on days forecast to be EXTREME (one level below CODE RED) on a case by case basis, with approval being given by midday the day before, so that families may be appropriately notified.

PERMISSION FORMS & PAYMENTS

Any notes, money, permission forms etc. throughout the year should to be returned to your homeroom teacher at the beginning of the school day in a marked envelope. 2023 FINANCIAL SUPPORT FOR FAMILIES

FINANCIAL ASSISTANCE

INFORMATION FOR PARENTS

Every Victorian child should have access to the world of learning opportunities that exist beyond the classroom. The Camps, Sports and Excursions Fund helps ensure that no student will miss out on the opportunity to join their classmates for important, educational and fun activities. It is part of making Victoria the Education State and the Government's commitment to breaking the link between a student's background and their outcomes.

CAMPS, SPORTS & EXCURSIONS FUND (CSEF)

School camps provide children with inspiring experiences in the great outdoors. Excursions encourage a deeper understanding of how the world works while sports teach teamwork, discipline and leadership. All are a part of a healthy curriculum.

CSEF is provided by the Victorian Government to assist eligible familles to cover the costs of school trips, camps and sporting activities.

If you hold a valid means-tested concession card or are a temporary foster parent, you may be eligible for CSEF. A special consideration category also exists for asylum seeker and refugee families. The allowance is paid to the school to use towards expenses relating to camps, excursions or sporting activities for the benefit of your child.

The annual CSEF amount per student is:

- \$125 for primary school students
- · \$225 for secondary school students

HOW TO APPLY


New applicants should contact the school office to obtain a CSEF application form or download from the website below.

If you applied for CSEF at your child's school last year, you do not need to complete an application form this year unless there has been a change in your family circumstances.

You only need to complete an application form if any of the following changes have occurred:

- new student enrolments; your child has started or changed schools this year.
- changed family circumstances; such as a change of custody, change of name, concession card number, or new siblings commencing this year.

Check with the school office if you are unsure.

CSEF ELIGIBILITY

Below are the criteria used to determine a student's eligibility for the Camps, Sports and Excursions Fund (CSEF).

Criteria 1 - General eligibility

To be eligible for the fund, a parent or carer of a student attending a registered Government or non-government Victorian primary or secondary school must:

- · on the first day of Term one
- · on the first day of Term two
- be a holder of one or more of the eligible financially-means tested cards OR be a temporary foster parent, and:
- b) submit an application to the school by the due date.

For the list of eligible financially-means tested cards refer to the CSEF Policy: https://www2.education.vic.gov.au/pal/camps-sports-and-excursions-fund/policy

Parents who receive a Carer Allowance on behalf of a child, or any other benefit or allowance not income tested by Centrelink, are not eligible for the CSEF unless they also comply with the above.

Criteria 2 - Be of school age and attend school in Victoria

For the purposes of CSEF, students may be eligible for assistance if they attend a Victorian registered primary or secondary school. CSEF is not payable to students attending pre-school, kindergarten, home schooled, or TAFE.

Special Consideration

A special consideration category exists for

- · Families on a bridging visa, temporary protection visa, in community detention or are asylum seeker families
- Students in temporary out of home care arrangements, including statutory kinship care

Eligibility Date

For concession card holders CSEF eligibility will be subject to the parent/carer concession card being validated successfully with Centrelink on the first day of either term one (30 January 2023) or term two (24 April 2023).

PAYMENT AMOUNTS

CSEF payment amount

The CSEF is an annual payment to the school to be used towards camps, sports and/or excursion expenses for the benefit of the eligible student.

- Primary school student rate: \$125 per year.
- Secondary school student rate: \$225 per year.

The CSEF is paid directly to your child's school and will be allocated by the school towards camps, sports and/or excursion costs for your child.

Year 7 government school students who are CSEF recipients are also eligible for a uniform voucher. Secondary schools are required to make applications on behalf of parents/carers so please register your interest at the school.

1. Complete the PARENT/CARER DETAILS section.

Make sure that the Surname, First Name, and Customer Reference Number (CRN) details match those on your concession card. You will also need to provide your concession card to the school.

If you are claiming as a temporary Foster Parent or a Veteran Affairs Pensioner, you will need to provide a copy of documentation confirming your status as a temporary Foster Parent or provide your Veterans Affairs Pensioner Gold card to the school.

If you are seeking special consideration, mark this in the form and provide a copy of the relevant documentation.

- 2. Complete the STUDENT/S DETAILS section for students at this school.
- Sign and date the form and return it to the school office as soon as possible. The CSEF program for 2023 closes on the 23 June 2023.
